### PROJECT COMPONENTS



NIA and DENR Tie the Knot for Jalaur

To ensure the protection and sustainability of the Jalaur River in Calinog as main source of the proposed Jalaur River Multipurpose Project Stage II (JRMP II), the National Irrigation Administration Region VI and the Department of Environment and Natural Resources Region VI tied the knot through a Memorandum of Agreement (MOA) titled "Watershed Resource Management Agreement for JRMP II" last January 16, 2014 at the DENR Activity Center.

The MOA was signed by the Regional Executive Director, Jim O. Sampulna of the DENR and NIA Regional Manager, Gerardo P. Corsiga, witnessed by Concurrent Asst. Project Manager - JRMP II, Jesus L. Dato-on, PENRO Raul L. Lorilla and RTD Livino B. Duran.

The MOA was formulated for proper delineation of watershed areas between the two agencies and for a continuous collaboration of programs and projects for reforestation and development of local communities in Calinog.

## REHABILITATION AND MODERNIZATION OF EXISTING NATIONAL IRRIGATION SYSTEMS WITHIN THE JRMP II AREA

### SUAGUE RIS DAM



1. Repair and rehabilitation of dam
2. Repair of dam structure and slope protection
3. Desilting of drainage number 1 (Augmentation canal 3.85 kilometers)
4. Improvement of drainage canal in Badlangan
5. Improvement of Lateral B-3 (5.22 kilometers)

### JALAU RIS DAM



1. Repair of main gates of Jalaur Dam (3 units)
2. Improvement of Old Lateral G drainage canal (3.98 kilometers)
3. Desilting of Puyaban Creek (2.84 kilometers)
4. Reshaping and desilting of main canal (11.0 kilometer), Lateral G (2.0 kilometers)
5. Desilting of main canal at Jalaur Extension (6.2 kilometers)
6. Reshaping and desilting of Lateral A at Jalaur Extension (2.0 kilometers)

### STA. BARBARA RIS DAM



1. Slope protection works at dam site
2. Desilting of main canal (4.92 kilometers)
3. Repair/modification of bifurcation steel gates
4. Improvement of drainage outfall-junction at Iloilo River (515 meters)

### SIBALOM RIS DAM



1. Repair and rehabilitation of dam
2. Rechanneling of river 1.0 kilometer upstream
3. Desilting of Lateral C (763 meters), Lateral A-4 (353.7 meters), drainage from Brgy. Umabang to Sibalom River
4. Repair of main canal service roads (Brgys. Anonang, Trapiche, Baras, Calam-isan, Burray and Galang)
5. Construction of main canal service road (Brgy. Sambaludan)
6. Construction of Lateral E service road (Brgy. Sambaludan)
7. Reshaping of irrigation canal from Lateral C to end check

Less 10% if paid by December 31  
with Discount: 1,530.00  
No Discount/No Penalty: January 1-31  
1% penalty per succeeding month starting February

#### Second Crop (Dry Season)

2,550.00/hectare  
Less 10% if paid by June 30  
with Discount: 2,295.00  
No Discount/No Penalty: July 1-31  
1% Penalty per succeeding month starting August
